


Aid-to-Localities funding to Virginia jurisdictions



#### Overview

VDFP is accredited to award certification by both the International Fire Service Accreditation Congress (IFSAC) and the Pro Board. With a cadre of more than 400 adjunct instructors, training and Operations delivers a portfolio of 130 different courses ranging from single-day to several months in length.

Virginia is one of a few states without a dedicated, state-run Fire Academy.

#### **Current Initiatives**

- Testing and rolling out online testing solutions
- Piloting modular training curriculum and processes
- •Re-aligning Accreditation and Certification and Learning Development Divisions to streamline processes



#### **Accreditation and Certification**

VDFP has streamlined the processing of certificates for accredited programs to include the Pro-Board seal. Any certificate issued for an accredited course completed after January 1, 2022, is now sealed and registered with Pro-Board saving our students and the localities an estimated \$72,000 annually. This means that upon successful completion of a course, students automatically receive certification with both IFSAC and Pro-Board for the levels to which the agency is accredited.

# FIRE & EMS MEMORIAL SERVICE




The 2023 Virginia Fallen Firefighters & EMS Memorial Service was held on Saturday, June 3, 2023 in Richmond.

Ten firefighters were recognized for their bravery and dedicated public service under the Virginia Line of Duty Act.

The 2024 service is scheduled for June 1, 2024.

### **HONOR - DUTY - RESPECT**

VDFP coordinates the Fire & EMS Memorial Service annually with a committee of approximately 10 dedicated personnel from Virginia's fire service and emergency community. Committee members volunteer their time and resources, and give selflessly to demonstrate how meaningful each honoree's sacrifice was to the fire service.



# LEGISLATIVE OVERVIEW

The 2023 session of the Virginia General Assembly contained multiple pieces of legislation that had a direct or indirect impact on the fire service. The Virginia Department of Fire Programs stood ready to assist stakeholders in addressing legislation, while also speaking on behalf of the Commonwealth of Virginia regarding fire service issues.

#### Legislation with direct impact to VDFP:

#### **HB1993**

This bill removes duplicate training for law enforcement fire marshals that hold prior certifications recognized by the Department of Criminal Justice Services. This change offers the locality an option to meet the basic law enforcement training requirement without attending BLE.

## **HB2133**

The State Fire Marshal or his designee will be the authority having jurisdiction over state-owned buildings, property, or structures related to fire safety and prevention. This bill clarifies that even if another state entity has a safety or security division, that ultimately the State Fire Marshal is the authority for fire safety and prevention.

## **HB1813**

This legislation would alter the definition of fireworks in the Commonwealth and curtail the ability of local fire marshals and the State Fire Marshal from enforcing the Statewide Fire Prevention Code on a new category of fireworks labeled "consumer" fireworks. This bill was defeated in committee.

## **HB2175**

This bill directed the Secretary of Public Safety and Homeland Security to convene a workgroup composed of various groups, state entities, and others to study Virginia's fire service. This group would examine fire service needs, funding, and the practices of other states to produce a report for the General Assembly. The report, drafted by VDFP, represented the first holistic review of funding for both fire and EMS in many years with 87% of localities reporting.

## HB2451

The legislation requires the Department of Fire Programs to develop a training program regarding electric vehicle fires. This would include both career and volunteer firefighters and must be implemented by July 1st, 2024. The legislation also requires all firefighters in the Commonwealth of Virginia to complete this training by December 1, 2025.

# **GRANTS SUMMARY**

#### Aid to Localities (ATL)

In the Aid to Localities (ATL) program, financial assistance is provided to cities, counties and incorporated towns throughout the state by offering a variety of grant opportunities to pay for training, construction of training centers, firefighting equipment and protective clothing. Allocations are population based.

ATL minimums are currently \$30,000 for counties and cities and \$15,000 for towns as approved by the Virginia Fire Services Board.

The FY2024 allocation is \$40,530,830 - an increase of 11.4% from FY23.

#### **FEMA Assistance to Firefighters Grant (AFG)**

The primary goal of the FEMA Assistance to Firefighters Grant (AFG) is to enhance the safety of the public and firefighters with respect to fire-related hazards by providing direct financial assistance to eligible fire departments, nonaffiliated Emergency Medical Services organizations, and State Fire Training Academies. This funding is for critically needed resources to equip and train emergency personnel to recognized standards, foster interoperability, and support community resilience.

VDFP received \$325,000 to purchase a mobile fire alarm and sprinkler system training laboratory. This project has been delayed due to supply chain issues but the shell of the training lab is under construction and will be ready in 2024. Once the shell is complete, the agency will bid the second part of the project for the procurement and installation of the internal components of the trailer.

#### Virginia Fire Incident Reporting System Hardware Grant (VFIRS)

VDFP awarded ten grants to localities totaling \$16,100 in FY23.





#### **Regional Fire Services Grants**

The Regional Fire Services Grant funding is utilized for the acquisition, renovation, repair, service, and management of fire services training props to provide training opportunities to multiple jurisdictions in support of training throughout the Commonwealth of Virginia per the NFPA 1001 and 1403 training standards. A locality may submit one application containing multiple training props but it is only allowed to receive a maximum award of \$50,000 unless a hardship is awarded. The Virginia Fire Services Board awarded a \$54,695 grant to: King and Queen County.


#### **Current Initiatives**

Based on available data, the median age of the victims was 69 years old. **The leading cause was electrical overload/malfunction.** Many of the victims had mobility issues that hindered timely evacuation.

# VIRGINIA EIRE MARSHAL ACADEMY

The VFMA provides training related to Fire Inspection, Fire Investigation, Environmental Investigations and Basic Law Enforcement for Fire Marshals throughout the Virginia.

In late summer of 2023, the Virginia Fire Marshal was moved back under the State Fire Marshal's Office. Since the restructure, the VFMA has continued to provide courses such as Fire Inspector (NFPA 1031), Fire Investigator (NFPA 1033), Basic Law Enforcement for Fire Marshals, and Environmental Investigations. The VFMA also supported the Virginia Fire and Rescue Conference and the First Responder Virginia Conference.

As we move forward into 2024 and beyond, the VFMA will be working with both our internal and external partners to prepare for the agency's reaccreditation. All of VFMA courses will be under review this year.

# SAFETY

#### **Overview**

The Chief Safety Officer(CSO) develops and oversees the effective development and implementation of policies, procedures, and systems that promote a safe and orderly environment for employees and students who participate in our training programs, including live fire structures. The CSO provides guidance on overall employee, and student, health and safety to include cancer prevention and mental health awareness. This position is also responsible for processing position specific 1582 physicals, manages the agency personal protective equipment, 1403 Live Burn training, ISO and HSO programs and related safety programs. This position will investigate all agency student and employee injuries. Additionally, the position serves in the ESF-4 position at the EOC and serves on the VEST for VDEM.

#### Cancer Prevention Course distributed via CSOD

This previously held in-person program was reconfigured as an on-demand course for our stakeholders to access at any time. Pre-incident, incident and post-incident preventative measures and best practices are presented during this course.

# Updated the Live Fire Training (1403) Program and Offering It On Demand via CSOD

This baseline course is intended for all personnel who are assisting with live burns, in any capacity. It covers basic NFPA 1403 safety information, best practices and rules to follow while functioning as part of a live burn cadre. Additional courses on this subject will be built out in the future in the same format.

#### **Developed Incident Safety Officer Course**

This course, which meets job performance requirements set forth in NFPA 1521, is a 2 1/2 day class that prepares the student to become an Incident Safety Officer (ISO) for their organization. This course covers firefighter health, reading smoke, technical events, alternative energy sources and more.



#### **Turnout Gear Cleaning Program**

Annual turnout gear cleaning was conducted again this year with a change in the process using direct mailing of the adjunct's turnout gear to the cleaning facility, and back to their residence. This process worked well with a 70% response rate.

#### FEMA Assistance to Firefighters Grant (AFG) for new SCBA's

VDFP will use this grant to purchase new SCBAs that meet current NFPA standards. The new SCBAs will be used by ARFF, Division Chiefs and instructional staff.

#### **Training Officer Quarterly**

Began a virtual round table to discuss burn building, training and safety related issues around the Commonwealth. Please reach out to Chief Dewhirst if you'd like to be included on the email list for this meeting.


#### **Training for VDFP Staff**

Worked with stake holders to deliver "Active Shooter" training and "Mental Health First Aid" for our staff members.

#### **GOALS FOR 2024**

- Successfully implement NFPA 1582 physicals, and mask fit testing, for adjunct instructors and VDFP Operational staff.
- Intake new SCBAs and train VDFP staff on their use.
- Begin developing new Health and Safety Officer curriculum via subject matter workgroup experts.
- Deliver the new ISO course eight times around the Commonwealth.
- Have 90% compliance on adjunct turnout gear cleaning.
- Reduce the number of student injuries during training by 10%.
