UNFINISHED BUSINESS

a. Goochland Live Fire Training Structure Presentation

Brandon Proffitt presented on their completed live fire training structure approved by the Virginia Fire Services Board. Goochland Fire Rescue Chief Eddie Ferguson and Goochland staff presented a plaque to the VFSB, accepted by Reeves Nobles and VFSB Chair Keith Johnson.

Ferguson thanked the board for their assistance on the project and Brandon Proffitt for his leadership throughout the project.

Johnson thanked Goochland for being a patient partner as the board and VDFP navigated a new prototype.

NEW BUSINESS

a. City of Roanoke New Building Application

Roanoke Fire-EMS Chief David Hoback spoke to the grant application. This included an overview of the city, its fire and EMS department, and capacity issues with the current regional training center. As the community has grown, there has been a need to train more firefighters. All the partners involved with the regional training center are seeing increased numbers in recruit schools, which has outpaced its capabilities for live fire training. In the past two and a half years, almost a third of the department has been replaced. This has also highlighted the need for additional incumbent training. The new training center being developed by the city will include space for state partners and classrooms but lacks a live fire training structure.

James Calvert stated he and members of the VFSB attended the Roanoke Regional Fire Academy Graduation and highlighted the regional concept. He supports the proposal based on the needs identified by Chief Hoback.

Jess Rodzinka asked for a vision of the new training center that the City of Roanoke will manage, which is where the structure will sit. Hoback stated it would be a Class A live fire training structure.

Reeves Nobles asked if they would be requesting the \$30,000 for architecture and engineering. Hoback stated this was the case and that the city manager supported the application.

b. Halifax County Extension Request

Jason Johnson spoke to the extension request. He highlighted ongoing issues with the project including the cost of bringing in dirt compared to demolishing the current building. The county does not have the permit in hand for the new structure, requiring an extension.

Reeves Nobles clarified if it was a two-year extension request or a one-year request. J. Johnson spoke about making sure the project is in line with state procurement policies and that could range from one to two years.

JM Snell II spoke about the issues identified with the site and that the locality is taking advice from the engineer. He supports the extension on those grounds and moved to extend the grant. Reeves Nobles asked Theresa Hunter to explain the competitive bid process. Hunter explained the process and that all projects must be put out to bid. Reeves Nobles asked if this made it feasible to meet this in one year. VDFP is looking at a 1.5-year benchmark.
